NOTICE OF ANNUAL GENERAL MEETING

1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the Annual General Meeting to be held on 25 June 2024.

2. PROPOSED RE-ELECTION AND APPOINTMENT OF DIRECTORS

In accordance with Articles 84(1) and 84(2) of the Articles of Association, Mr. Chan Yiu Sing ("Mr. Chan"), Mr. Ding Baoshan ("Mr. Ding") and Mr. Kuo Dah Chih, Stanford ("Mr. Kuo") shall retire at the Annual General Meeting.

Reference is made to the announcement of the Company in relation to the proposed change of independent non-executive Directors dated 24 April 2024. Mr. Ding Baoshan will not offer himself for re-election and will therefore retire at the Annual General Meeting whereas the other retiring directors of the Company, i.e. Mr. Chan, and Mr. Kuo, being eligible, will offer themselves for re-election at the Annual General Meeting. Mr. Ding will cease to be the chairman of the Remuneration Committee and the member of the Audit Committee and Nomination Committee of the Company upon his retirement. Mr. Ding confirmed that he has no disagreement with the Board or the Company and there is no other matter relating to his retirement that needs to be brought to the attention of the shareholders of the Company and the Stock Exchange.

Pursuant to the laws, regulations and the Articles of Association, upon approval by the Board, Mr. Lam Yin Shing, Donald ("Mr. Lam") has been nominated as a candidate for the position of independent non-executive Director of the Company. His appointment is subject to the consideration of and approval by the Company's Shareholders at the Annual General Meeting. The term of office will come to effect on the date when the Shareholder's approval at the Annual General Meeting is obtained.

In reviewing the nomination of Mr. Lam, the Nominating Committee considered the qualifications and work experience of Mr. Lam and is of the view that Mr. Lam possesses the requisite experience and capabilities to assume the responsibilities as an independent non-executive Director. The Board having reviewed and considered the Nomination Committee's assessment of Mr. Lam, is also of the view that Mr. Lam possesses the requisite experience and capabilities to assume the responsibilities as an independent non-executive Director.

Each of Mr. Kuo and Mr. Lam has confirmed his independence with reference to the factors set out in Rule 3.13 of the Listing Rules. The Nomination Committee has reviewed the composition of the Board, the confirmations and disclosures given by each of Mr. Kuo and Mr. Lam, the qualifications, skill and experience, time commitment and contribution of each of Mr. Kuo and Mr. Lam with reference to the nomination principles and criteria set out in the Company's board diversity policy and the Company's corporate strategy, and the independence of each of Mr. Kuo and Mr. Lam. The Nomination Committee has recommended to the Board on re-election of the retiring Directors including the aforesaid independent non-executive Director who is due to retire at the Annual General Meeting and the appointment of Mr. Lam as an independent non-executive Director. The Board accepted the recommendations made by the Nomination Committee and considers that each of Mr. Kuo and Mr. Lam is independent in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules.

Mr. Lam has extensive management experience in the banking and finance industry. Mr. Lam will facilitate diversification of the members of the Board and make contribution to the Board with his professional financial knowledge and corporate governance direction, in order to help the Board better promote the implementation of development strategy and plans of the Company. The Board also considers that Mr. Chan, Mr. Kuo and Mr. Lam, have different culture, educational and professional background and have abundant experiences in their respective areas of expertise. The Board believes that Mr. Chan, Mr. Kuo and Mr. Lam will bring, their respective valuable experience, skills and perspectives to the Board with a view of contributing to the diversity of the Board.

Details of the Directors to be re-elected and appointed at the Annual General Meeting are set out in Appendix I to this circular.

3. PROPOSED GRANTING OF GENERAL MANDATE TO REPURCHASE SHARES

At the annual general meeting of the Company held on 27 June 2023, a general mandate was granted to the Directors to repurchase Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Share Buy-back Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,039,808,000 Shares.

Subject to the passing of the ordinary resolution set out in item 5 of the notice of the Annual General Meeting in respect of the granting of the Share Buy-back Mandate and on the basis that the issued share capital of the Company remains unchanged on the date of the Annual General Meeting, i.e. being 1,039,808,000 Shares, the Directors would be authorised under the Share Buy-back Mandate to repurchase, during the period in which the Share Buy-back Mandate remains in force, a total of 103,980,800 Shares, representing 10% of the total number of Shares in issue as at the date of the Annual General Meeting.

2. REASONS FOR SHARE BUY-BACK

The Directors believe that the granting of the Share Buy-back Mandate is in the best interests of the Company and the Shareholders as a whole.

Share buy-back may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders as a whole.

3. FUNDING OF SHARE BUY-BACK

The Company may only apply funds legally available for share buy-back in accordance with its Articles of Association, the laws of Cayman Islands and/or any other applicable laws, as the case may be.

4. IMPACT OF SHARE BUY-BACK

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2023) in the event that the Share Buy-back Mandate was to be carried out in full at any time during the proposed share buy-back period. However, the Directors do not intend to exercise the Share Buy-back Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

6. GENERAL

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective close associates have any present intention to sell any Shares to the Company in the event that the granting of the Share Buy-back Mandate is approved by the Shareholders.

The Company has not been notified by any core connected persons of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company in the event that the granting of the Share Buy-back Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to repurchase Shares pursuant to the Share Buy-back Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

Neither this explanatory statement nor the proposed share repurchase has any unusual features.

7. TAKEOVERS CODE

If as a result of a buy-back of Shares pursuant to the Share Buy-back Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. Accordingly, a Shareholder or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholder's interest, could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

To the best knowledge of the Company, as at the Latest Practicable Date, Mr. Lu Yuguang, the Chairman, an executive Director and a controlling shareholder of the Company, and Grandview Capital Investment Limited, which is a company wholly-owned by Mr. Lu Yuguang, in aggregate own 640,500,000 Shares representing approximately 61.59% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Buy-back Mandate in full, the aggregate shareholding of Grandview Capital Investment Limited and Mr. Lu Yuguang would be increased to approximately 68.44% of the issued share capital of the Company, assuming there is no other change in the issued share capital of the Company.

The Directors are not aware of any consequences which may give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code.

The Directors do not propose to exercise the Share Buy-back Mandate to such an extent as would, in the circumstances, give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code or result in the aggregate number of Shares held by the public Shareholders falling below the prescribed minimum percentage required by the Stock Exchange.

8. SHARE BUY-BACK MADE BY THE COMPANY

During the 6 months prior to the Latest Practicable Date, the Company had not repurchased any of the Shares (whether on the Stock Exchange or otherwise).
